The Town of Malone IDA Board makes accessible Town property and finances to enhance the quality of life of its citizens.


The Town of Malone IDA Board supports its citizenry and businesses in their efforts to improve the community facilities and environment.

The managers lead the Town of Malone's departments to improve the efficiency of the functions of the town.



The managers are constantly monitoring the safety and well being of the community by carefully upgrading and repairing infrastructure such as roads, sewer, Industrial Park and the environment.
